NOTES

A. METHOD OF APPLICATION

- (1) Letters from both Proposer and Seconder should accompany this form, stating fully the position of the Candidate socially and otherwise, his qualifications for membership, and the length of time they have known him, which should not ordinarily be less than two years.
- (2) It would be of assistance to the Committee if the Candidate could also be supported by Members other than the Proposer and Seconder.
- (3) J7 applicants (those to apply for membership within 18 months of leaving a school affiliated to the Headmaster Conference) may only be proposed by their Headmaster. No Seconder is required.
- (4) The son of a Member need only be proposed by his father. No Seconder is required.
- (5) A candidate's Proposer and Seconder must have been members of the Club for at least two years.
- (6) A candidate may be required to attend an interview.
